Location:

The conference will be held at the University Campus. The University is located in the middle of the city center of Eindhoven, nearby the train station. Eindhoven is located in the southern part of The Netherlands and has its own modern, international airport. Eindhoven is famous for the creation of the light-bulb by Philips in 1891. A little later, the first DAF truck was created in Eindhoven. These events started the development and flourishing of the city. Since then Eindhoven has grown to become one of the most prominent cities of Europe in the fields of technology, knowledge and design.

Travel:

You can get direct flights to Eindhoven Airport from various cities in Europe: e.g. Alicante, Barcelona, Budapest, Dublin, London, Madrid, Milan, Prague, Stockholm. In a 15 minutes drive from Eindhoven Airport, the city centre of Eindhoven can be reached. Besides that, you can reach Eindhoven easily by train or special airport taxi from the large international Airport Schiphol (Amsterdam). Trains run every 30 minutes from Schiphol directly to the centre of Eindhoven.
